## Payden Absolute Return Bond Fund (the “Fund”)

Payden Absolute Return Bond Fund – Sterling Class (Accumulating) (ISIN:IE00B973TK71)

A sub-fund of Payden Global Funds public limited company (the “Company”)

The Manager is Waystone Management Company (IE) Limited (the “Manager”)

### Objectives and investment policy

The Fund aims to achieve a return of 300 basis points above the ICE BofA Overnight Rate Index in the relevant share class currency over a 3-year period, while seeking preservation of capital.

The investment manager will actively select, purchase and sell securities with the aim of meeting the investment objectives of the Fund.

In order to achieve its objective the Fund will invest predominantly in a wide variety of fixed and floating rate investment grade and below investment grade debt instruments and income-producing securities traded on regulated markets worldwide, including money-market securities.

The Fund may also invest up to 15% in equities and equity related instruments.

The Fund may use derivatives with the aim of managing interest rate and currency risk more efficiently.

The Fund may also use derivatives for both hedging purposes and for taking investment positions. These may include short positions where the Fund seeks to benefit from the sale of an asset that it does not physically own.

Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within 12 months.

Your shares are accumulating, meaning that income and gains of the Fund will be reinvested to increase the value of the Fund.

Your shares are denominated in Sterling. The Fund’s base currency is US Dollars. Typically, assets held by the Fund which are denominated in a currency other than the base currency may be hedged or substantially hedged to the base currency. The base currency is in turn hedged to Sterling in this share class or to the currency of denomination of the relevant share class for other classes.

Shares can normally be bought and sold on any business day, being a day on which banks are open for business in Ireland, the UK and the US.

The impact of portfolio transaction charges may be material due to the strategy adopted by the Fund. Such costs are paid from the assets of the Fund in addition to the ongoing charges set out below.

The Fund is actively managed with reference to the ICE BofA Overnight Rate Index in the relevant share class currency (the “Index”) by virtue of the fact that it seeks to outperform the Index. The investment manager has discretion over the composition of the Fund. Whilst the investment manager does not employ a defined strategy to align with a benchmark during periods of volatility, it will take account of market environment and perceived risks at any given time and will employ its investment discretion as described in the investment policy accordingly.

### Risk and reward profile



The risk indicator was calculated using representative historic performance data and may not be a reliable indicator of the risk profile of the Fund.

The risk category shown is not guaranteed and may change over time. The lowest category does not mean your investment is ‘risk free’.

The Fund is rated 3 because of the medium level of risk due to the nature of its investments in debt instruments. The following risk factors may give rise to performance volatility and may expose the Fund to losses: (i) the value of the Fund will rise as bond yields generally fall but will fall in the event that bond yields generally rise; (ii) changes in the perceived credit worthiness of bond issuers will contribute to performance volatility. A fall in credit worthiness will generally lead to a fall in the value of the Fund and vice versa; and (iii) while the assets held by the Fund which are denominated in a currency other than the base currency are mostly hedged back to the base currency, currency risks will not be eliminated.

The risk indicator is measured on a share class basis. Where share classes of the Fund have temporarily differing risk indicators, the representative share class will show the higher risk category.

Material risks not adequately captured by the risk indicator include:

**Counterparty Risk:** The insolvency of any institutions providing services such as custody or acting as counterparty to any transaction may expose the Fund to financial loss, including counterparties to derivatives and foreign exchange trades.

**Credit Risk:** An issuer may fail to repay income or capital in full, leading to a financial loss for the Fund.

**Liquidity Risk:** There may be some circumstances in which the ability to sell certain assets at little cost will be impaired.

**Derivative Risk:** Gains and losses from the use of derivatives may be greater than where the underlying investment is purchased directly by the Fund.

**Emerging Market Risk:** Emerging economies may exhibit higher levels of investment risk.

**Operational Risk:** There may be risks associated with the safekeeping of the assets by the Depositary and sub-custodians.


The charges you pay are used to pay the costs of running the Fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.

## Past performance
